- 90 decibels are too loud measured "at their property line" means they are playing louder than 90. 60-70 range is more prevalent.
- What are the criteria to approve permit?—checklist zoning, proximity to homes.
  - o residents should be informed of applications and be part of the conversation.
  - o how long is the permit for?
  - o Permits should be displayed in window.
- If the music is the attraction, the location should be treated as a *venue*.
- Gas Leaf blowers are also loud.
- Noise is problem throughout community: loud music, garage bands at all hours.

**Resolution #230921N** - A motion was made by Trustee Cuocci seconded by Trustee Prizzi and carried authorizing the Village Clerk to engage a forensic auditor previously approved by Resolution # 230906P for an amount not exceeding \$25,000.

**Resolution #2309210** – A motion was made by Trustee Cuocci seconded by Trustee Lang and carried authorizing unspent bonded funds borrowed for the MFD ladder truck, be applied to the fiscal 2024 principal and interest payment for the truck.
