The meeting was called to order at 7:40 pm.

The Pledge to the Flag was recited followed by a moment of silence in memory of Joseph Dean, Robert H. Glasser Sr., Gary Osborn, Deanna Zullo Maietta

Mayor's Update – Whelan Park was recently opened. The Mayor shared the progress to date. He updated the residents on recent plans and approvals for 61 Church Street and the Village's efforts to lessen the concerns of residents in the area. 1 Britton Circle will be retained and become the new home of Carbone Park. The Board intends to sell the current Carbone Park. The business district looks great, filled storefronts, exciting new businesses and renewed focus. The LIRR will finish up their work on the tracks between Hempstead Avenue and Valley Stream in the fall. The gas station application for the corner of Hempstead Avenue and Ocean Avenue is working its way through Nassau County approvals. The Atlas Court subdivision was approved for 3 lots by the Malverne Planning Board. The Mayor revealed the roads that will be included in our fall paving which will begin between Mid-October and Thanksgiving.

The Mayor presented a citation to Matteo Somma for his athletic, academic, and civic achievement and contributions to the community.

Public Input

Maria Casini – Malverne Chamber of Commerce announced the new business that have recently joined the Chamber. The Chamber Fall Festival and Classic Car Show will be Saturday, September 20th.

Maria Casini - LIJ Valley Stream Community Board introduced the Executive Director of the hospital, Janson Tan who provided an update on recent changes and new programs that will greatly benefit the community.

Carol Hassett reported on the success of the 2025 Walk-a-Thon. The American Legion Family is currently collecting school supplies for military families throughout the month of August, with drop-off locations at the Village Hall and Library. In addition, they are preparing for a Military Family Baby Shower to be held on September 20th, supporting families with children

from birth to age three—donations of clothes and diapers are especially needed. Their next meeting will take place on September 10th at the Post Hall. The group is also planning a *Night at the Races* event on November 1st.

Marion Dill – 70 Charles Street congratulated the Board on the completion of Whelan Park. She asked about the progress at the Movie Theatre. She questioned the process for reporting vacant properties in disrepair. Deputy Mayor Edwards directed her to call Village Hall.
